WARRANTY COVERAGE

Midwest Enterprises Warranties that our E-Z-GUTTER GUARD SYSTEM will be manufactured free of defects with our patented exclusive design. This warranty is limited to the exclusions, limitations, conditions and legal rights stated in this Warranty.

WARRANTY DOES NOT COVER

Midwest Enterprises has no control over the installation of the Product. Midwest Enterprises is not responsible for improper installation of the Product.

Any unauthorized modifications will terminate Midwest Enterprises' responsibilities under this Warranty.

Cosmetic damage, or damage due to acts of nature, including but not limited to, ice, floods, hail, wind, storm, tornado, earthquake, hurricane or fire, or due to damage caused by extraordinary impact events, such as dropping or crushing, or impact by foreign objects.

Midwest Enterprises has no control over fading or discoloration of the Product or its components, and as such, color changes of the Product are not covered by this Warranty.

Like all gutter protection products, E-Z-GUTTER GUARD SYSTEM requires maintenance from time to time, (Specifically mildew, moss, tree sap, and insect or bird droppings) like brushing off the top of the panels. Any expense or cost incurred to clean any blockage or obstruction including those which are determined to be below grade will not be covered under the Warranty.

REGISTRATION AND TRANSFER

To activate this Warranty, the original purchaser and the installing contractor must fill out, sign and mail in the registration certificate within 30 days of the installation date.

To transfer this Warranty, you must send a copy of the title transfer of the property shown on the registration certificate, and a copy of the original registration certificate within 30 days after the transfer, along with a money order or check for \$50.00 for the transfer.

CLAIMS

To initiate a Warranty claim, contact the installation company for service and resolution within the Warranty period and within a reasonable period of time after the defect is discovered. There may be a service charge if the service calls are for non-warranty repair or adjustments. All other inquiries may be sent to Midwest Enterprises Customer Service Department, P.O. Box 345, St. Clair, MO. 63077. A copy of your registration certificate, as well as a description of the claimed defect and the date the defect was discovered, are required to make a Warranty claim. Midwest Enterprises will notify you if any additional information is needed or required.

PANEL REPLACEMENT

This Warranty provides for the replacement of the Product or its components (with the same or compatible design or color) which are shown to be defective under normal or proper use. No other remedies are available under this Warranty other than replacement of the Product or its components. Midwest Enterprises reserves the right to change or discontinue any design or color of the Product for Warranty replacement.

Midwest Enterprises does not warrant and will not be responsible for any cost, defects or damage with respect to the removal or re-installation of the Product or its components.

EXCLUSIONS, LIMITATIONS, CONDITIONS

This Warranty is made in lieu of and supersedes all other warranties or conditions of merchantability or fitness for a particular purpose or general use, whether express, implied, collateral, statutory, or provided by common law, the Uniform Commercial Code, or otherwise. No other express warranty or guaranty given by any other person, firm, or entity with respect to the product shall be binding on Midwest Enterprises. Replacement of the Product is the exclusive remedy under this Warranty.

Midwest Enterprises shall not be liable for any incidental or consequential damages caused by the use, misuse or inability to use the Product. These include but are not limited to any damages in the form of lost profits, loss of use, legal fees, economic loss, personal injuries, or any other damages caused by circumstances beyond the control of Midwest Enterprises.

Notwithstanding the foregoing, Midwest Enterprises' aggregate liability to any customer shall not exceed the purchase price of the Product. No person is authorized to alter, extend, or waive the Warranty of Midwest Enterprises.

Some states do not allow the exclusion or limitation of incidental or consequential damages, or allow limitations on warranties, so the above limitations or exclusions may not apply to you. This Warranty gives you specific rights, and you may have other rights, which vary from state to state. The exclusions and limitations to the Warranty apply to the maximum extent permitted by law and unless restricted or prohibited by law. Where any term of this Warranty is prohibited by applicable law, it shall be null and void, but the remainder of this Warranty shall remain in effect.
